Self-study reports were received for six of the eight programs to be reviewed. Programs reviewed included: Range and Wildlife Management, Agribusiness, English, History, Music/Performance, and Computer Information Systems. Because Music and Performance are nationally accredited programs, these programs were reviewed by an ad-hoc subcommittee only, with the accreditation site visit report of 2006 serving in lieu of an additional external review. The UPRSC is still awaiting submission of external review reports for Agribusiness and Computer Information Systems. As soon as these reports are received, they will be forwarded to the respective department chairs and deans, as well as the Office of the Provost.

Programs scheduled for review in 2008-2009 which were not reviewed included: Finance and Applied Arts and Sciences. The UPRSC recommends that the Finance program review be completed in 2009-2010. This request is being made on the basis of this program having an interim chair during 2008-2009. The UPRSC recommends that the review of the Applied Arts and Sciences program be deferred until 2010-2011. The Applied Arts and Sciences program was transferred from the College of Business Administration to University College in 2007-2008. Deferral of the review of the BAAS program will allow time for University College to develop and implement strategies for building this program, as well as time to gather data on the program's performance. Given this time, a valid self-study can be prepared and a realistic plan of action developed for future enhancement of the program.
